### **COVID-19 Warning**

We have taken enhanced health and safety measures--for you, our other guests, and our employees. All persons are required to follow all posted instructions while vacationing at Smugglers' Notch Resort.

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and/or death. According to the Centers for Disease Control and Prevention, senior citizens and guests with underlying medical conditions are especially vulnerable.

### **Certificate of Compliance**

Lodging operations may accept overnight guests from Vermont residents, travelers from a county with a similar active COVID-19 caseload as Vermont as identified by the Agency of Commerce and Community Development, or travelers from a high-risk area (a case load greater than 400 active cases per million) if those travelers have done or can do the following:

*Travelers may complete either a 14-day quarantine or a 7-day quarantine followed by a negative test in their home state and enter Vermont without further quarantine restrictions if they drive directly from their home via their personal vehicle. Travelers may complete a 14 day quarantine or a 7 day quarantine followed by a negative test in a Vermont lodging establishment regardless of destination origin or manner of travel (travelers must stay in their quarantine location for the duration of quarantine other than to travel to and from a test site).*

*Travelers are encouraged to register with the Sara Alert upon arrival in Vermont to get two weeks of daily reminder to check for common symptoms of COVID-19. <https://apps.health.vermont.gov/EpilInfoWebSurvey/Home/9c2e5941-1ba7-4ab4-84be-558ba7684f5d>*

1. I certify that:

- A. I am a critical worker as defined by the State of Vermont; OR
- B. I have not left the state of Vermont for any reason except essential travel in the past 14 days; OR
- C. I have been in a county in CT; MA; MD; ME; NH; NJ; NY; OH; PA; RI; VA; Washington, D.C.; or WV with fewer than 400 active COVID-19 cases per million, as set forth on the Vermont Agency of Commerce and Community Development's website\*, and I did not travel to Vermont by air or bus; OR
- D. I have traveled to Vermont from another state, and I traveled directly from my home in my personal vehicle, and I have completed a 14-day self-quarantine (or a 7-day self-quarantine followed by a negative test result) in that state; OR
- E. I have traveled to Vermont from another state, and I will complete a 14-day self-quarantine (or a 7-day self-quarantine followed by a negative test result) in Vermont at a lodging establishment or residence, and I acknowledge that I must stay in my quarantine location for the duration of the quarantine. During this time I will absolutely refrain from use of Smugglers' programs and facilities to comply with this requirement. (Smuggs' staff is available and happy to assist you with delivery of groceries and takeout meals. Please feel free to contact the Guest Service Desk at 802-644-1293 to make arrangements.)

2. I also certify that I have not had close contact within the past 14 days with a person confirmed to have COVID-19.

3. I also certify that I do not currently, and have not had in the past 24 hours, any of the following symptoms:

- Cough;
- Difficulty breathing;
- Fever (feeling feverish or have a measured temperature at or above 100.4°F/38°C);
- Used a fever reducer (in the past 24 hours, have you used any medicine that reduces fevers?);
- Chills;
- Repeated shaking with chills;
- Muscle pain;
- Headache;
- Sore throat;
- New loss of taste or smell.

4. I also certify that all persons in my care who are under the age of 18 years or who are dependent on my care meet the criteria described in 1–3 above. Please provide a list of the names of all such persons in your reservation.

5. By way of this form, I have been informed that out-of-state guests are encouraged to register with the Vermont Department of Health’s Sara Alert system\* and to provide updates to that system daily.
